Should not be used on floors with a deflection greater than the joist span divided by 360. Joist span must comply with NZS3604. Tiles larger than 400mm X 400mm may require reduced deflection criteria. Dimensional instability in natural stone ranges is often difficult to detect visually and may require thermal and moisture stability testing to ensure that adhesive recommendations are suitable. Do not use in layers thicker than 10mm.

Some DUNLOP Tile Adhesives may be used over some DUNLOP Undertile Waterproofing and Acoustic Systems. DUNLOP Universal tile adhesive is suitable for use in swimming pool applications
